### **General Business**

- The Committee approved that coverage determination will go to the Claims Review Committee 2 (CRC2) and then will go to the General Liability 2 (GL2) Committee to make the final determination.
- Staff and the Committee discussed the Program Funding Strategy. The Committee agreed with staff's recommendation to incorporate a 5% surcharge. Once the premiums are in the process of being finalized, the Committee will discuss a final determination.
- The Committee reviewed recommended amendments to the portion of the Alliant Brokerage Agreement pertaining to the GL2 Program. They took action to recommend approval of those amendments to the Executive Committee with minor changes to Addendum A-2 and Addendum D, and continuing with a maximum commission rate of 6.25%.
- PRISM staff provided an informational report regarding the additional capital contribution by the GL2 Program to PRISM ARC.
- Staff and the Committee discussed GL2 claims audits. The Committee accepted
  the audits and would like direction from the Executive Committee on how to handle
  the matter.

- The Committee approved staff's recommendation to increase the GL2 Program limit to \$35M at renewal.
