Program Performance Report (PPR)

Staff presented the PPR, updated through March 31, 2022. Premium volume for all combined program segments is \$148M, with medical/pharmacy claims and fixed costs totaling \$143M, resulting in a program funding ratio of 98.7%.

Carrum Health and Hinge Health Update

Alliant presented an update on the Carrum Health and Hinge Health programs that highlighted additional services, plan enhancements and current enrollment. The Committee approved the continuation of Carrum Health services at the current rate of \$0.75 per employee, per month, effective January 1, 2023, through December 31, 2024.

Livongo Diabetes Management Update

Alliant presented an update on the Livongo Diabetes Management program, including a program communication strategy to date, and current enrollment. The Committee approved the continuation of Livongo Diabetes Management services at an increased rate of \$70 per participant per month, effective January 1, 2023.

2023 Program Fixed Administrative Costs and Program Renewal

The Committee approved the fixed costs for the 2023 PRISMHealth Program renewal, effective January 1, 2023.

2023 PRISMHealth Program Renewal

Alliant presented the 2023 pool renewal and member specific CPRA adjustments for the PRISMHealth Program. As approved by the Committee, the 2023 PRISMHealth Program blended pool renewal is an 8.86% increase in premium.

Express Scripts (ESI) Mid-Year Formulary and Exclusions Update

The Committee reviewed the bi-annual ESI formulary changes that are effective July 1, 2022. Alliant included a list of excluded medications, affected members, and discussed the strategy to communicate with the 19 impacted subscribers.

New Member Applications

The Committee reviewed and approved the both the County of Glenn and the City of Ventura for entry into the PRISMHealth Program, large member segment, effective January 1, 2023.

Other Matters

- Staff reminded the Committee of the PRISMHealth Program withdrawal provisions contained in the program MOU.
- Alliant provided an update on CalPERS health plans, including possible 2023 renewal ranges.
