**2024 Chair & Vice Chair**

The Committee selected Lance Sposito as the Chair and Victor Tordesillas as the Vice Chair for 2024.

**General Business**

- The Committee approved a methodology to allocate the deductibles for the 2022/23 winter storm losses;
- The Committee received an update on the 2024/25 excess renewal and negotiations, a market update, and a summary of recent meetings with the underwriters for reinsurers and excess insurers;
- Staff reviewed with the Committee the actuarial results and funding for the Pool layer was determined. The Committee approved setting the Pool funding at \$130M, discounted (\$125.6M); binding the renewal with BHSI with a \$150M attachment point; binding the \$130M Agg Stop Loss Layer (\$130M attachment point & \$20M limit) for a premium up to \$9M; and binding the renewal with Fidelis for the \$15M xs \$10M layer for premium up to \$42M;
- The Committee directed staff to continue with cost saving measures for the Program, which included offering higher deductibles. Staff will bring additional information to the Committee at a future meeting;
- Staff provided a report on the return of the PRISM ARC capital contribution;

- The Committee approved financial assistance to fund loss prevention/risk management programs by awarding applicable grants, up to \$25,000 per member, per fiscal year;
- The Committee approved modifying coverage from RCV to ACV for the Fisherman's Wharf Plaza in Ventura County;
- The Committee received an informational report recapping the 2023 Strategic Planning Retreat; and
- Staff informed the Committee on new member services and programs.
