

## The largest wildfire in the US has grown about 1,000 acres every hour: July 16, 2021

The Bootleg Fire, the largest wildfire in the United States this year, has scorched more than 240,000 acres since it first started 10 days ago in southern Oregon, according to the latest report from InciWeb.

That means the blaze has spread around 24,000 acres per day on average, or just over 1,000 acres every single hour. That's an area larger than the area of Central Park each hour, or a rate of a football field burned every 5 seconds for 10 days, CNN meteorologist Brandon Miller said.

The fire, which began July 6 in the Fremont-Winema National Forest and on private lands near the town of Sprague River in Oregon, has charred 241,497 acres and remains just 7% contained, according to InciWeb, the clearinghouse for wildfire information across the country. Communities around Summer Lake and the town of Paisley were being evacuated, officials reported on the Bootleg Fire Facebook Page. Because of "extreme wildfire behavior," crews pulled back early from vulnerable areas and were regrouping, the Facebook page said.

"The Bootleg Fire perimeter is more than 200 miles long. That's an enormous amount of line to build and hold," said Rob Allen, incident commander for the Pacific Northwest Area Incident Management Team 2, in an online update.

The fire has also impacted transmission lines used to import electricity to California, officials said.

"This fire is going to continue to grow -- the extremely dry vegetation and weather are not in our favor," said Joe Hessel, an incident commander for the Oregon Department of Forestry.

Bootleg is one of 10 wildfires currently burning in Oregon, which was recently baked in the historic heatwave that swept across the West.

The fire has destroyed at least 21 homes and put another 2,000 at risk, state fire officials said.

The severity has led California officials to send even more firefighting resources to the state.

"California's latest mutual aid deployment to Oregon comes just a day after the National Multi-Agency Coordinating Group elevated the National Preparedness Level to Level 5 -- its highest level -- due to high fire activity across the country and resources committed to large fires," Gov. Gavin Newsom's office said in a news release. As of Thursday, the United States was grappling with 71 fires and complexes that have burned 993,678 acres so far, according to the National Interagency Fire Center.

In addition to the nation's largest in Oregon, the Log Fire was sparked northeast of The Bootleg Fire and has charred nearly 5,000 acres.

In Washington state, the fast-moving Red Apple Fire in Chelan County that began July 13 has burned 11,000 acres and remains 10% contained, according to Inciweb.

Authorities have placed 1,500 homes under evacuation notifications, the Chelan County Sheriff's Office said in a news release. Meanwhile, California's Butte County is battling the Dixie Fire, which has grown to 2,200 acres with no containment, according to CAL Fire. Residents there are also under evacuation warnings.

## Weather

An upper low will remain off the Pacific Northwest coast today with southwest flow aloft for the Northwest and northern Great Basin, and portions of the Northern Rockies. Elevated conditions will continue in the afternoon for the interior Northwest, northern Great Basin, and portions of northern California and Northern Rockies. Isolated dry thunderstorms are possible for east central Idaho into Southwest Montana and northern Wyoming during the afternoon. Scattered wet thunderstorms are likely for Utah, Colorado, southern Wyoming, and the Southwest. Localized flash flooding will remain possible over southeast Arizona and southwest New Mexico. A cold front will move through the eastern Great Lakes and Ohio Valley with locally heavy rain and potential flooding. Temperatures are forecast near average for California and the Northwest, but remain above normal for the Great Basin, Northern Rockies, northern Plains and Great Lakes. Southwest flow is forecast for Alaska with above normal temperatures for the southern and central Interior.
