

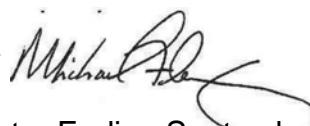

RE: Investment Report for the Quarter Ending September 30, 2016

The quarterly investment report required by Government Code 53646 is respectfully presented. All investments conform to the requirements of Government Code 53601 and the investment policy.

All anticipated cash flows for at least 12 months can be comfortably met. As of September 30, 2016 there were \$192.7 million in cash equivalents and securities that will mature in less than one year in the Liquidity and Short Term Core portfolios managed by Chandler Asset Management, plus an additional \$55.0 million held in EIA's LAIF account. All of the securities in the respective portfolios are marketable and can be immediately converted into cash.

The EIA investment portfolio is of high quality and is well diversified and secure. The consolidated investment portfolio, as of September 30, 2016, was evaluated as follows:

The attached quarterly investment report, excluding the LAIF activity, was prepared by Chandler Asset Management, an outside party EIA has contracted to manage its investment portfolio on a discretionary basis. The report reviews recent economic data impacting the fixed income markets, provides a detailed account profile for each of the portfolios (including performance versus the respective benchmarks), consolidated portfolio information, portfolio holdings, a transactions report (in accordance with California Government Code 53607), and a monthly interest earnings report over the reporting period.

This completes the Treasury report required by Government Code 53646. A comprehensive treasury report is presented at each meeting of the Board of Directors. We encourage each Board Member to attend these meetings and review these matters. We also encourage you to share this report with other appropriate officials.



CSAC EIA / Performance Evaluation

July – September 2016

The Federal Open Market Committee (FOMC) kept the fed funds rate unchanged at a range of 0.25%-0.50% during the third quarter. The Fed's overall assessment of the economy was essentially the same in July and September. However, there were three dissenting votes (out of ten) at the September meeting, as Esther George (Kansas City), Loretta Mester (Cleveland), and Eric Rosengren (Boston) preferred to raise the target range by a quarter percent. In the September policy statement, the Committee noted the labor market continued to strengthen but inflation remained below target. If economic data remains modestly favorable over the next few months, we expect the Fed will hike the fed funds rate range by 25 basis points in December. The market-implied probability of a December rate hike, based on fed funds futures pricing, is currently greater than 65%.

Market participants estimate the economy grew at an annualized pace of about 2.7% in the third quarter. If accurate, that represents a pick-up from first and second quarter GDP growth of 0.8% and 1.4%, respectively. The consensus forecast calls for GDP growth of about 2.3% in the fourth quarter. Labor market trends remained favorable during the third quarter, which should continue to provide a tailwind to economic growth. The unemployment rate was 5.0% in September, wage growth ticked higher, and payrolls increased by an average of 192,000 per month during the third quarter (more than enough to absorb new entrants into the labor market). Consumer confidence remains strong.

Global financial markets recovered in the third quarter, following the market turbulence that ensued at the end of the second quarter caused by the United Kingdom's surprising vote to leave the European Union, known as "Brexit". Expectations for a fed funds rate hike before year-end increased during the third quarter. The European Central Bank left monetary policy unchanged in the quarter, disappointing some investors that had anticipated additional stimulus. The Bank of England initiated a series of monetary measures focused on stimulating the economy during Brexit. Macroeconomic data continued to indicate lackluster growth and low inflation in the Eurozone region. The Bank of Japan continued to provide stimulus to the sluggish Japanese economy during the quarter. Looking ahead, concerns about global economic growth and ongoing uncertainty about global central banks' monetary policies will likely continue to fuel financial market volatility. In addition, the long-term implications of the Brexit vote, the stability of the European Union, and the global political climate (including the outcome of the upcoming US Presidential election) are also uncertain and likely to cause volatility.

During the third quarter, the yield curve shifted upward with the 2-year Treasury yield up 18 basis points and the 10-year Treasury yield up nearly 13 basis points. Corporate credit spreads, or the additional compensation investors receive for purchasing non-US treasury securities, tightened during the third quarter, based on the Bank of America Merrill Lynch US Corporate Index. However, we continue to see a modest deterioration in the credit fundamentals of some corporate issuers as a result of weaker earnings and re-leveraging. Meanwhile agency spreads remain tight, as supply continues to be constrained.

Performance Summary – Short Term Core Portfolio

- Chandler commenced management of the portfolio on January 31, 2015.
- For the three month period ending September 30, 2016 the portfolio returned (0.02%) versus (0.07%) for the Bank of America Merrill Lynch 1-5 Year US Corporate and Government AAA-A Index.
- For the 12 month period ending on September 30, 2016 the portfolio returned 1.81%, matching the return of the Bank of America Merrill Lynch 1-5 Year US Corporate and Government AAA-A Index.
- The relative outperformance during the quarter was driven by the term structure differentiation of the portfolio versus the benchmark. In particular the modest barbell structure, with the portfolio overweight short and longer duration securities, positively contributed to the performance of the portfolio.
- Portfolio Transactions
 - Multiple securities were purchased across the investable universe to keep the portfolio structure in-line with Chandler objectives.
 - The purchased securities ranged in maturity from March 2017 to September 2021.
 - Three securities were sold, two were called, and one matured, in addition to a net \$26 million contribution into the portfolio to facilitate the new securities in the portfolio.
- Portfolio Sector
 - The sector allocation was relatively stable.
 - Some of the notable changes include the 3.0% reduction in the Treasury allocation, to 31.1% of the portfolio, partially offset by the 2.2% increase in the Supranational allocation, to 3.1% of the portfolio.
- Portfolio Duration
 - The duration of the portfolio was close to unchanged, currently 2.39 versus 2.41 at the end of the prior reporting period.
 - The Chandler team will continue to keep the overall duration of the portfolio below the benchmark due to the underpricing by the market of the risks of a tightening in monetary policy later in the year.

Performance Summary – Liquidity Portfolio (Does not include LAIF)

- Chandler commenced management of the portfolio on January 31, 2015.
- For the three month period ending September 30, 2016 the portfolio returned 0.11% versus 0.02% for the custom index and 0.10% versus the three month Treasury bill index.

- For the 12 month period ending September 30, 2016 the portfolio returned 0.41% versus 0.60% for the custom index and 0.24% for the three month Treasury bill index.
- Due to the cash flow needs of the Authority the liquidity portfolio has consistently maintained a duration well short of the custom index, leading to the underperformance versus the custom index over the 12 month time horizon.
- Portfolio Transactions
 - Many securities were purchased across the investable universe to offset upcoming estimated cash flows out of the EIA portfolio later in the Authority's fiscal year.
 - The purchased securities ranged in maturity from October 2016 to May 2017.
 - Multiple securities matured in addition to a net \$36.8 million contribution into the portfolio were utilized to facilitate the purchase of the new securities.
- Portfolio Sector
 - The sector allocation changed based on the large cash flows, both positive and negative.
 - Some of the notable quarter-over-quarter differences include the 5.3% increase in the Commercial Paper allocation, to 7.8% of the portfolio, partially offset by the 4.2% decline in the Corporate allocation, to 20.3% of the portfolio.
- Portfolio Duration
 - The duration of the portfolio increased, currently 0.41 versus 0.21 at the end of the prior quarter.
 - The increase in duration is primarily attributable to the larger estimated cash flows not happening until the first and second quarters of 2017.

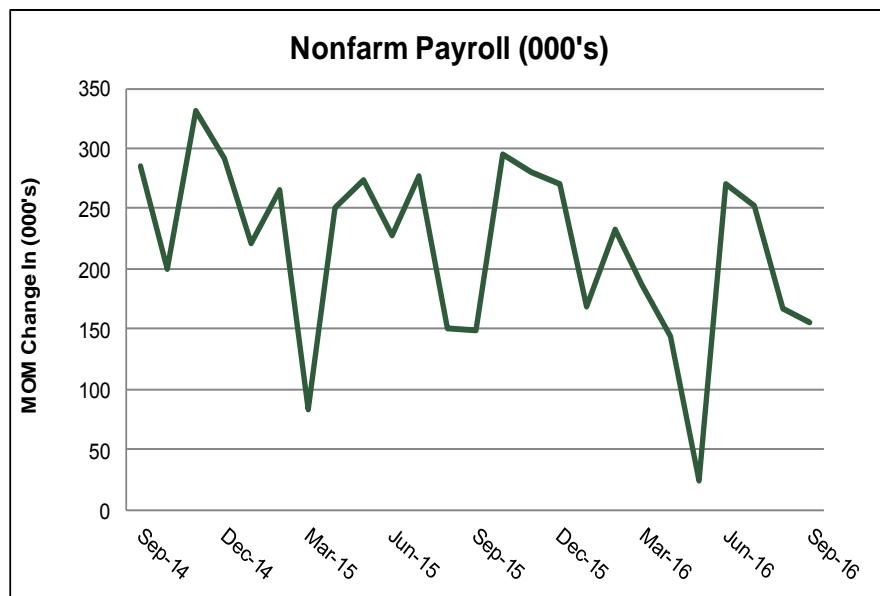

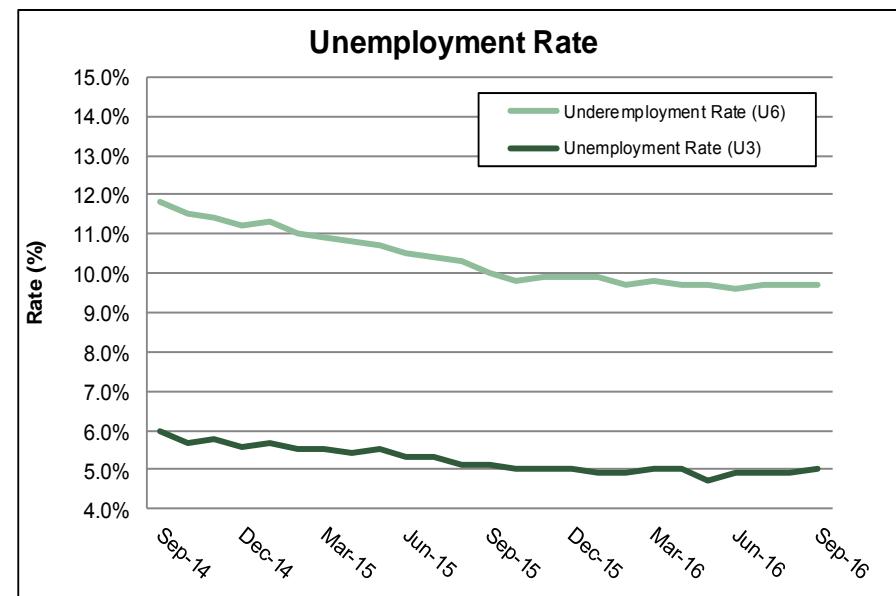


Economic Update

- The Federal Open Market Committee (FOMC) kept the fed funds rate unchanged at a range of 0.25%-0.50% in September. However, there were three dissenting votes (out of ten), as Esther George (Kansas City), Loretta Mester (Cleveland), and Eric Rosengren (Boston) preferred to raise the target range by a quarter percent. The Fed's overall assessment of the economy was little changed from July. In the policy statement, the Committee noted the labor market has continued to strengthen but inflation remains below target. In deciding whether or not to raise the fed funds target rate, the Committee said "the case for an increase in the federal funds rate has strengthened but decided, for the time being, to wait for further evidence of continued progress toward its objectives." In her press conference, Fed Chair Yellen remarked that the next meeting on November 1-2 is a "live" meeting but given its proximity to the US Presidential election on November 8, we think the Fed is likely to keep monetary policy on hold until December. If economic data remains modestly favorable over the next few months, we expect the Fed will hike the fed funds rate range by 25 basis points in December.
- The global economy continues to face headwinds, but domestic economic data points toward ongoing slow growth. The U.S. labor market remains healthy. The unemployment rate was 5.0% in September, and payrolls have increased by an average of 192,000 on a trailing 3-month moving average basis. Wage growth is inching higher. Consumer confidence remains strong. Housing trends remain favorable even though home price appreciation has softened. Oil prices have rebounded from earlier this year. The manufacturing sector, though still under pressure, has slightly improved. Second quarter 2016 GDP grew 1.4%, following growth of 0.8% in the first quarter. The consensus forecast calls for a pick-up in GDP growth in the second half of the year to 2.9% and 2.4% in the third and fourth quarters, respectively.
- In September, the 2-year Treasury yield decreased four basis points and the 10-year Treasury yield increased one basis point. Leading up to the FOMC meeting in September, the yield curve steepened slightly. After the FOMC meeting in September, yields modestly declined. The market-implied probability of a fed funds rate hike before year-end (reflected in fed funds futures prices) is now greater than 60%. According to the Fed's most recent projections, 14 out of 17 policymakers project at least one rate hike before year-end. The Fed's longer-run fed funds rate forecast is now 2.9%. The Fed's "dot plot" of fed funds rate projections has drifted lower over the last few years and we believe the projected terminal fed funds rate of 2.9% remains unrealistically high. We expect it will continue to move down closer to 2.0%. At least over the near-term, we believe multiple global and domestic factors will create an effective cap on rates across the yield curve.

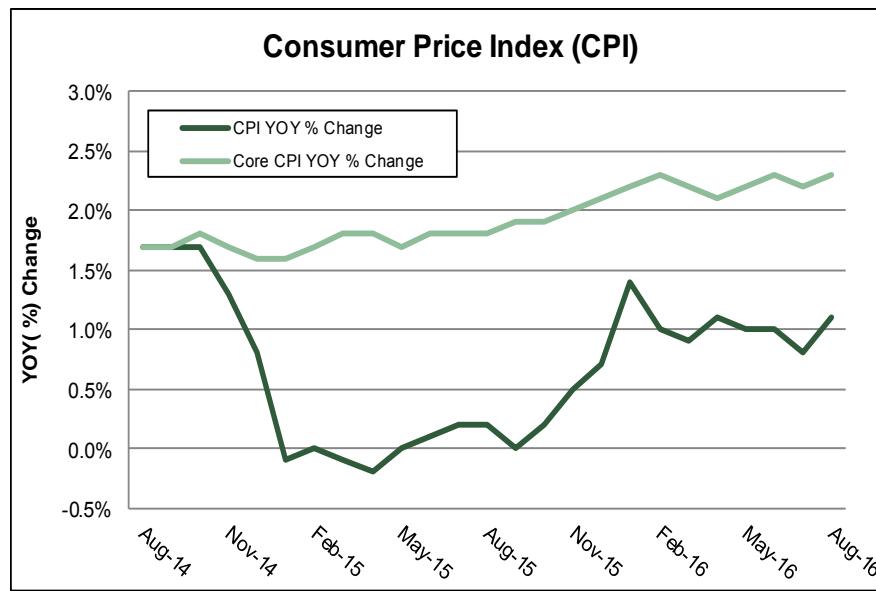

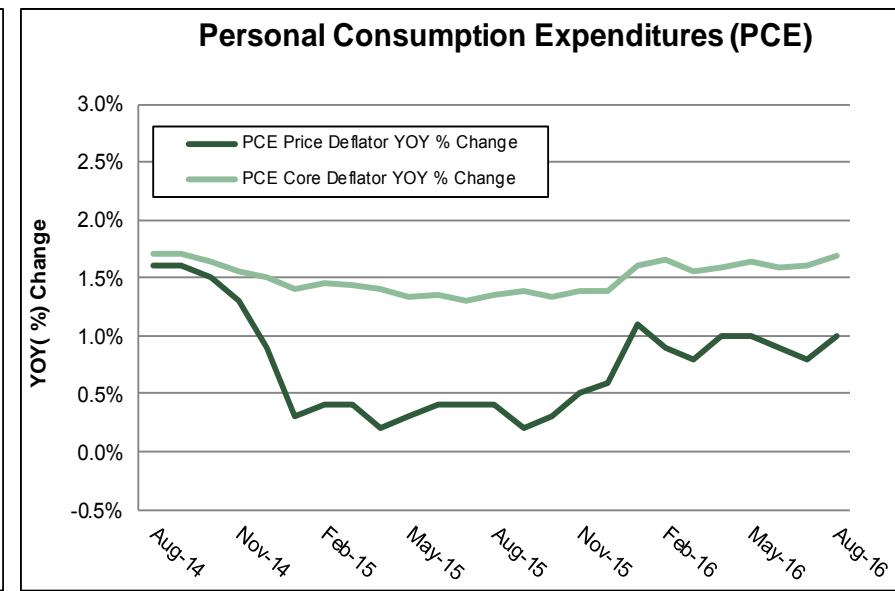

Nonfarm payrolls were lower than expected in September, up 156,000 versus the consensus forecast of 172,000. July and August payrolls were revised down by a net total of 7,000. On a trailing 3-month and 6-month basis, payrolls increased by an average of 192,000 and 169,000 per month, respectively. The unemployment rate inched up in September to 5.0% from 4.9% in August, as the participation rate increased to 62.9% from 62.8%. A broader measure of unemployment called the U-6, which includes those who are marginally attached to the labor force and employed part time for economic reasons, remained unchanged in September at 9.7%. Wages increased 0.2% in September, following a 0.1% increase in August. On a year-over-year basis, wages were up 2.6% in September, versus 2.4% in August.

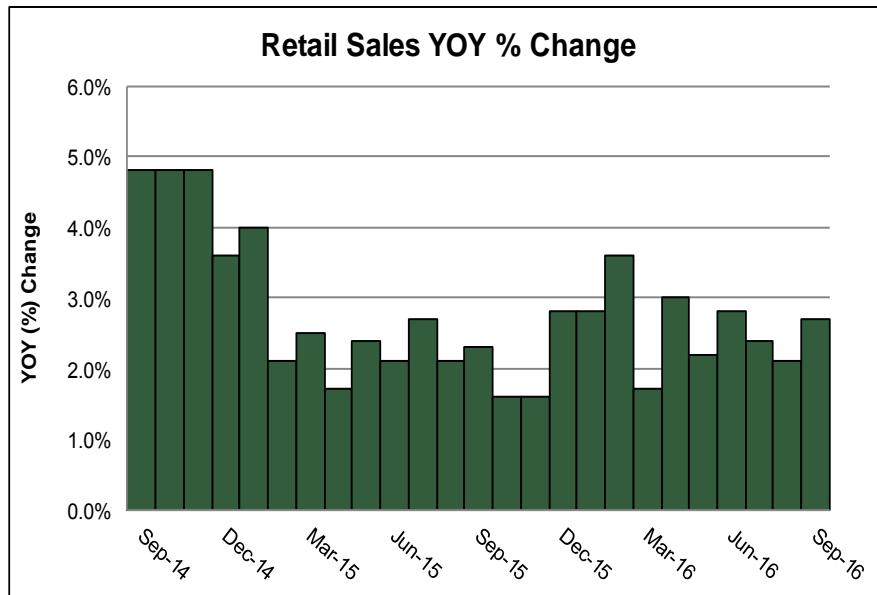

The Consumer Price Index (CPI) was up 1.1% year-over-year in August, versus up 0.8% year-over-year in July. Core CPI (CPI less food and energy) was up 2.3% year-over-year in August, vs. 2.2% in July. The Personal Consumption Expenditures (PCE) index was up 1.0% year-over-year in August, versus 0.8% in July. Core PCE (excluding food and energy) was up 1.7% year-over-year in August vs. up 1.6% year-over-year in July. Although Core CPI is trending above 2.0%, the Fed's primary inflation gauge is PCE which remains below the Fed's 2.0% target.

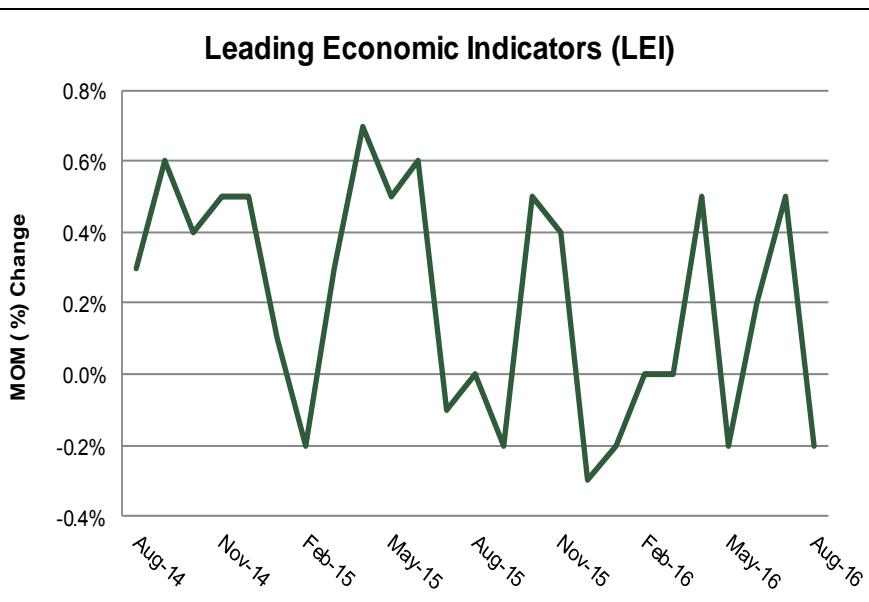

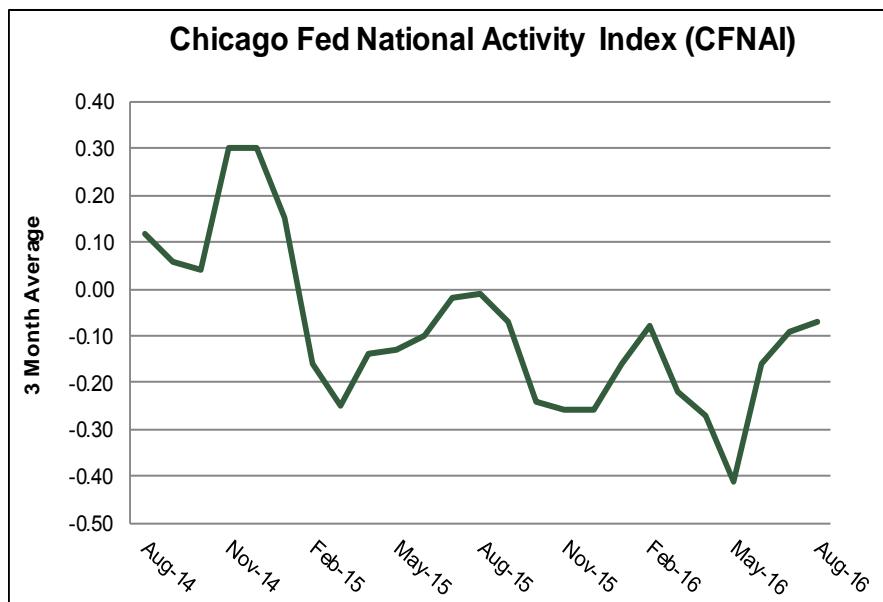

On a year-over-year basis, total retail sales were solid, up 2.7% in September compared with a 2.1% increase in August. On a month-over-month basis, retail sales were up 0.6% in September, in line with expectations. Excluding autos and gas, retail sales rose 0.3% in the month. Meanwhile, consumer confidence remains strong. The consumer confidence index rose to 104.1 in September from 101.8 in August.

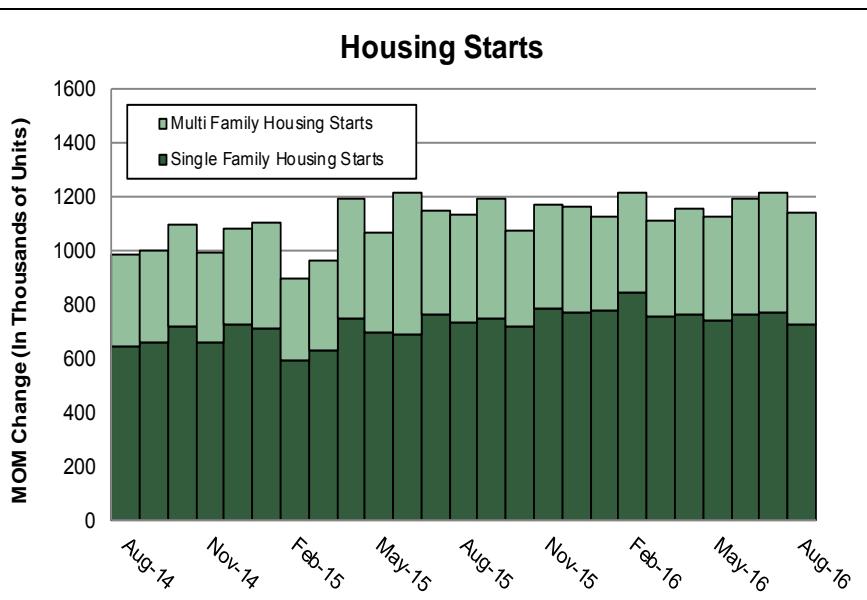

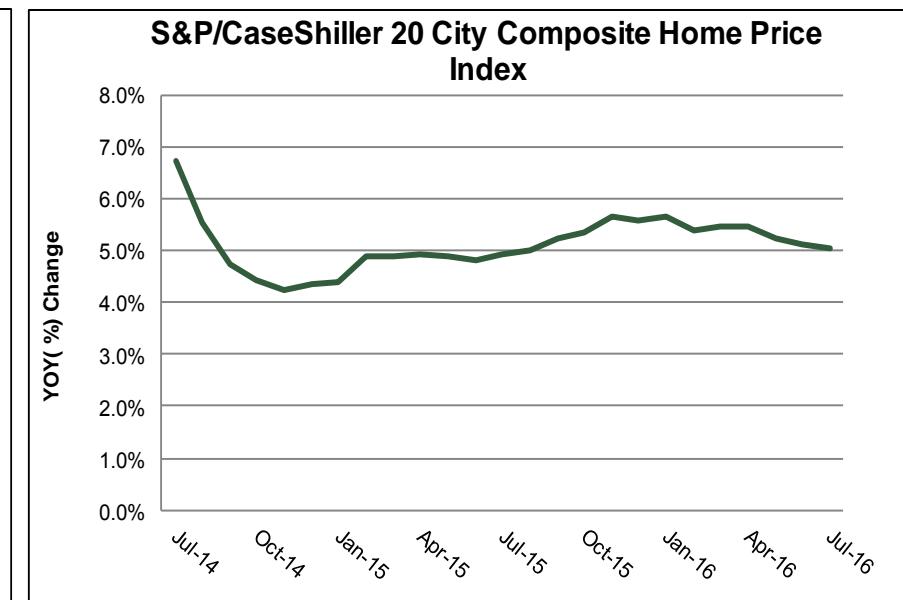

The Index of Leading Economic Indicators (LEI) declined 0.2% in August, below expectations. Meanwhile, the Chicago Fed National Activity Index (CFNAI) improved to -0.07 in August on a 3-month moving average basis, from -0.09 in July. Both broad economic indices point to weak economic growth ahead.



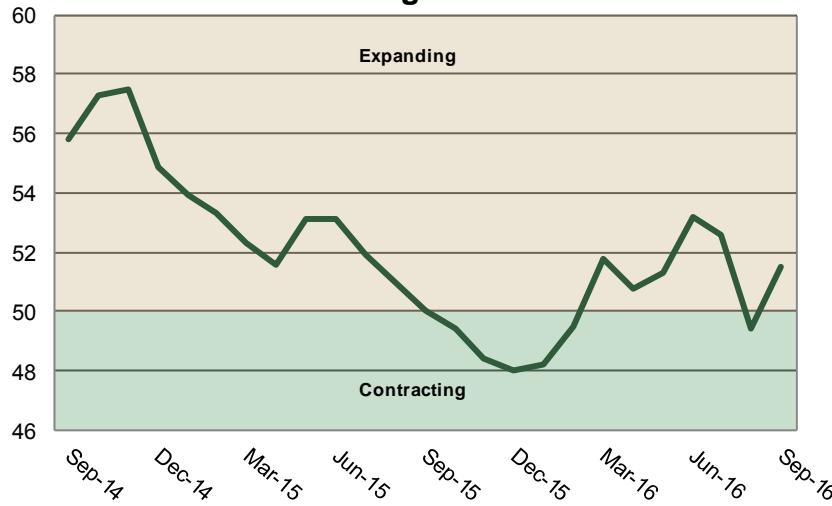

Total housing starts fell 5.8% in August, following growth of 1.4% in July. Single-family starts fell 6.0% in August while multi-family starts declined 5.4%. Housing starts tend to be volatile on a month-to-month basis but the underlying trend remains favorable. Notably, single-family permit growth was strong in August. According to the Case-Shiller 20-City home price index, home prices were up just 5.0% year-over-year in July, vs. up 5.1% year-over-year in June. This index suggests that home price appreciation continues to soften.

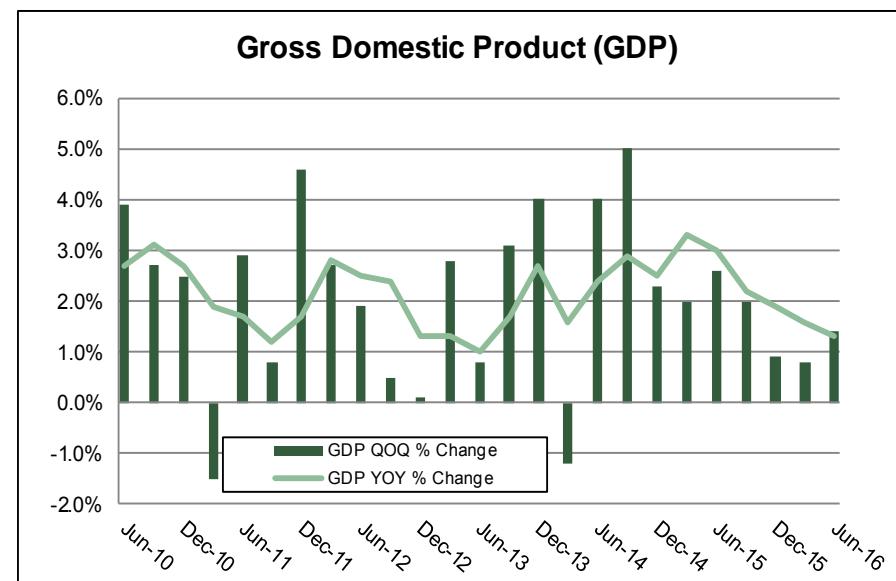
The Institute for Supply Management (ISM) manufacturing index increased to 51.5 in September from 49.4 in August, suggesting that manufacturing activity is improving. New orders grew solidly in September. A reading above 50.0 suggests the manufacturing sector is expanding, and a reading above 43.1 is generally indicative of broad economic expansion, based on the historical relationship between the index and GDP growth. Meanwhile, capacity utilization, which is production divided by capacity, decreased to 75.5% in August from 75.9% in July. The capacity utilization rate remains below the long-run average of 80.0% (1972-2015), suggesting there is still excess capacity in the industrial sector.

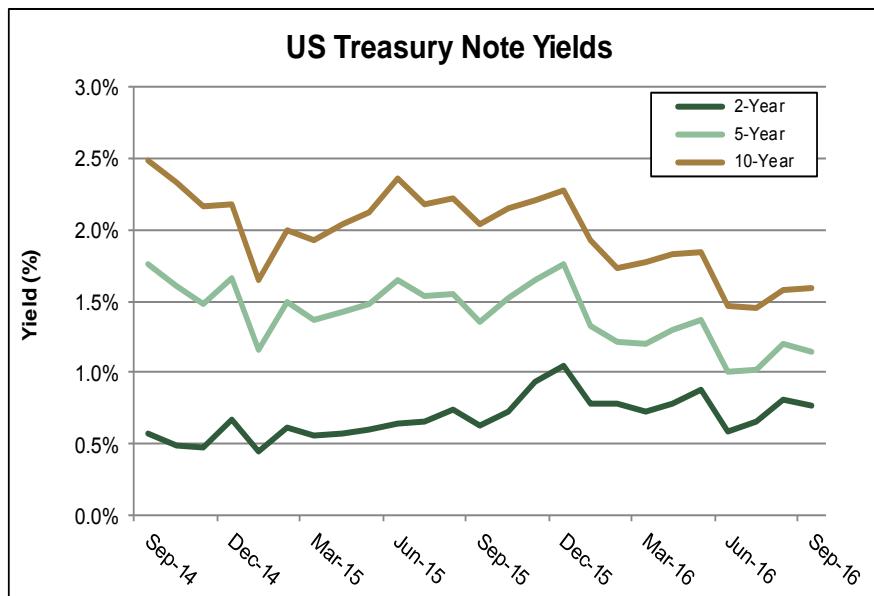

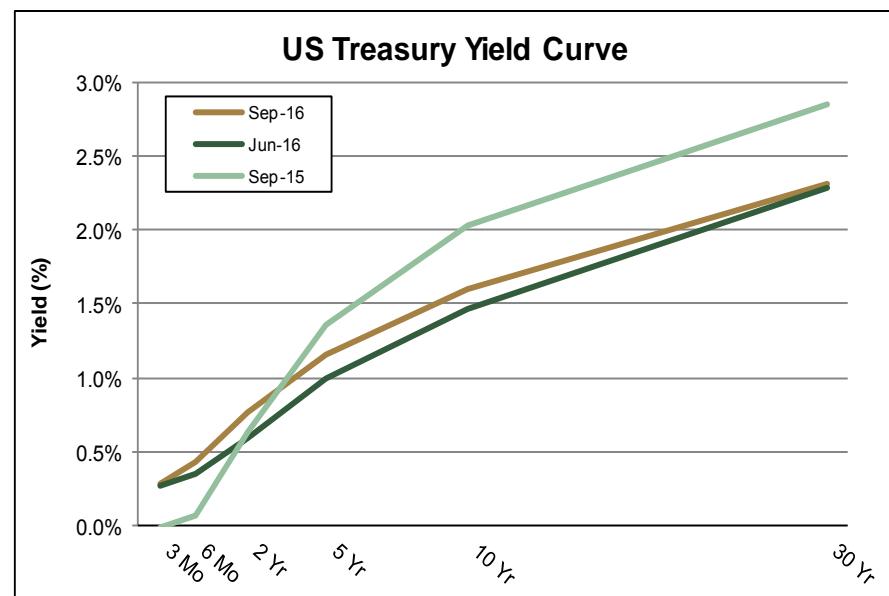

Second quarter real GDP growth was revised up to an annualized rate of 1.4% from the second estimate of 1.1%, slightly exceeding expectations. This follows growth of 0.8% in the first quarter and 0.9% in the fourth quarter. Nonresidential investment, exports, and inventories were the primary drivers of the revision. Growth from Personal Consumption Expenditures (PCE) was strong in the second quarter and continued to be the biggest overall contributor to economic growth. Market participants are forecasting GDP growth of 2.9% in the third quarter.

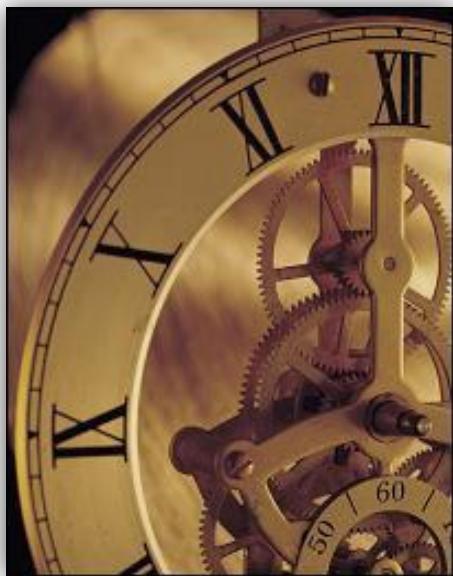

Over the past three months, the yield curve shifted upward with the 2-year Treasury yield up 18 basis points and the 10-year Treasury yield up nearly 13 basis points. However, on a year-over-year basis the yield curve flattened with the 2-year Treasury yield up about 13 basis points and the 10-year Treasury yield down more than 44 basis points. Over the past year, financial market volatility has been elevated due to weak global economic growth, volatile commodity prices, political uncertainty, and divergent global central bank monetary policy.



SECTION 2

Account Profile

Investment Objectives

The investment objectives of the CSAC Excess Insurance Authority (the “Authority”) Short Term Core Portfolio and the Liquidity Portfolio are first, to provide safety of principal to ensure the preservation of capital in the overall portfolio; second, to provide sufficient liquidity to meet all operating requirements that may be reasonably anticipated; and third, to attain a market rate of return throughout budgetary and economic cycles.

Chandler Asset Management Performance Objectives

The performance objective for both accounts is to achieve a rate of return over a market cycle that equals or exceeds the return on a market index of similar duration and sector allocation.

Strategy

In order to achieve these objectives, the portfolios are invested in high-quality fixed income securities with a maximum maturity of five years.

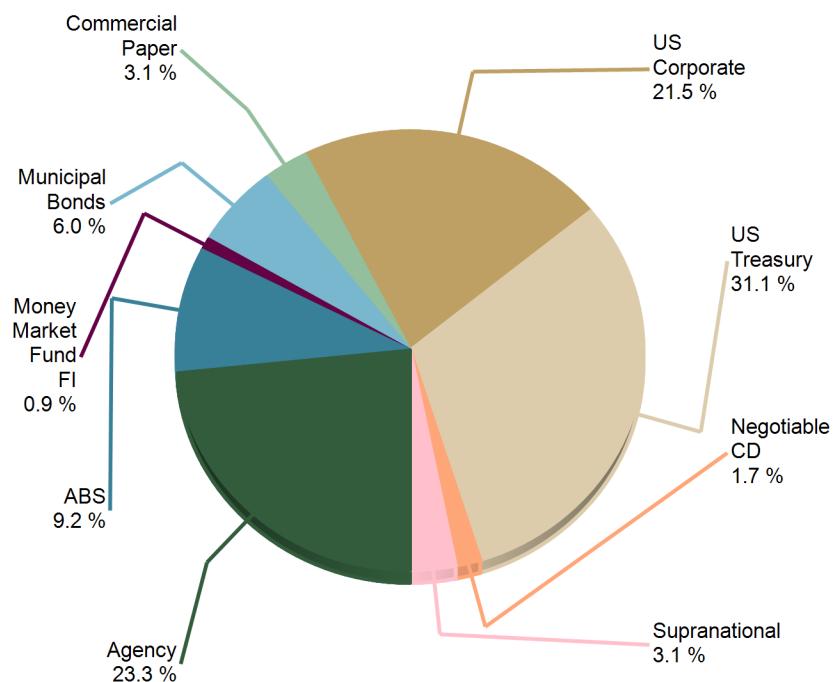

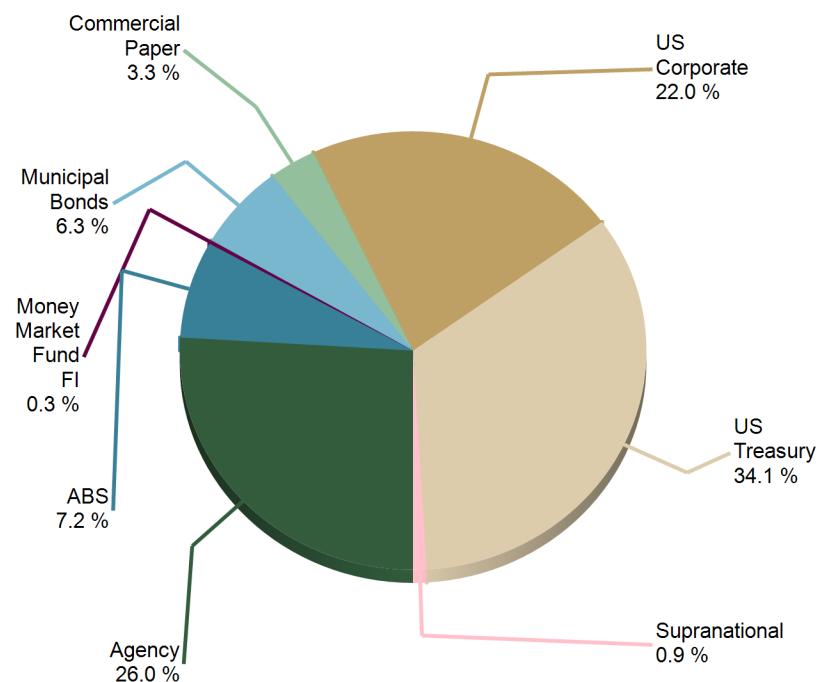

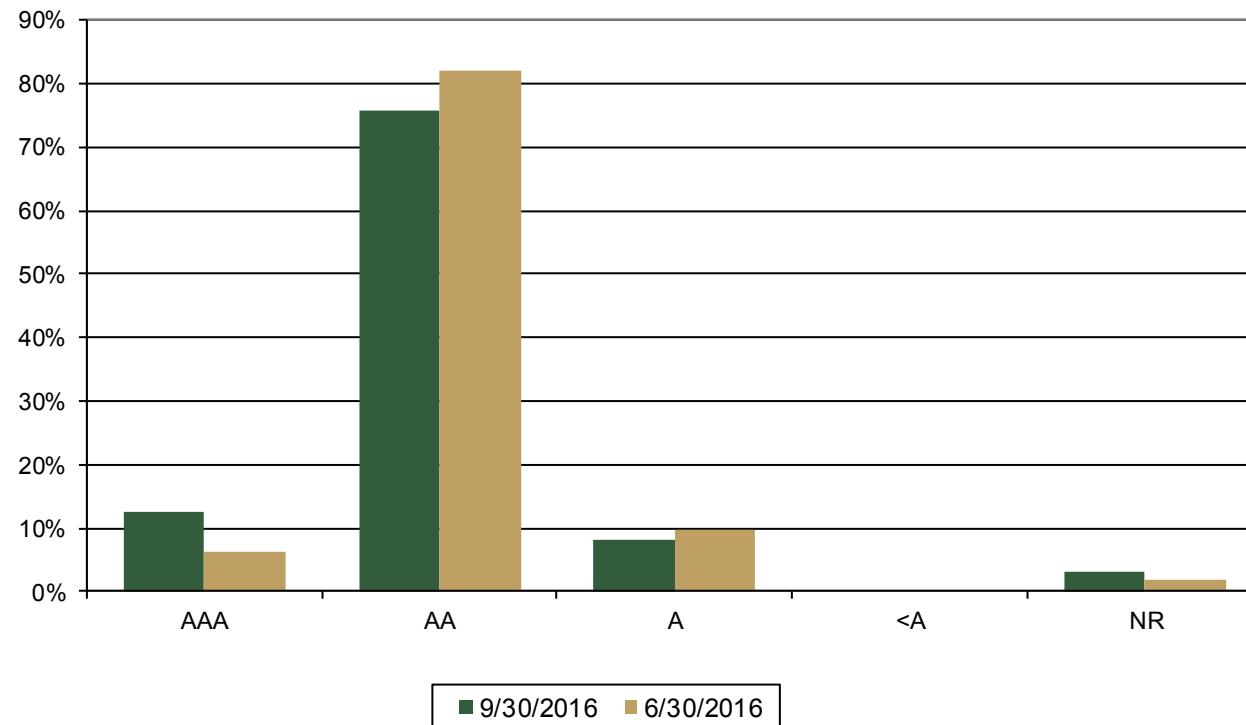

CSAC-EIA Short Term Core Portfolio September 30, 2016 vs. June 30, 2016



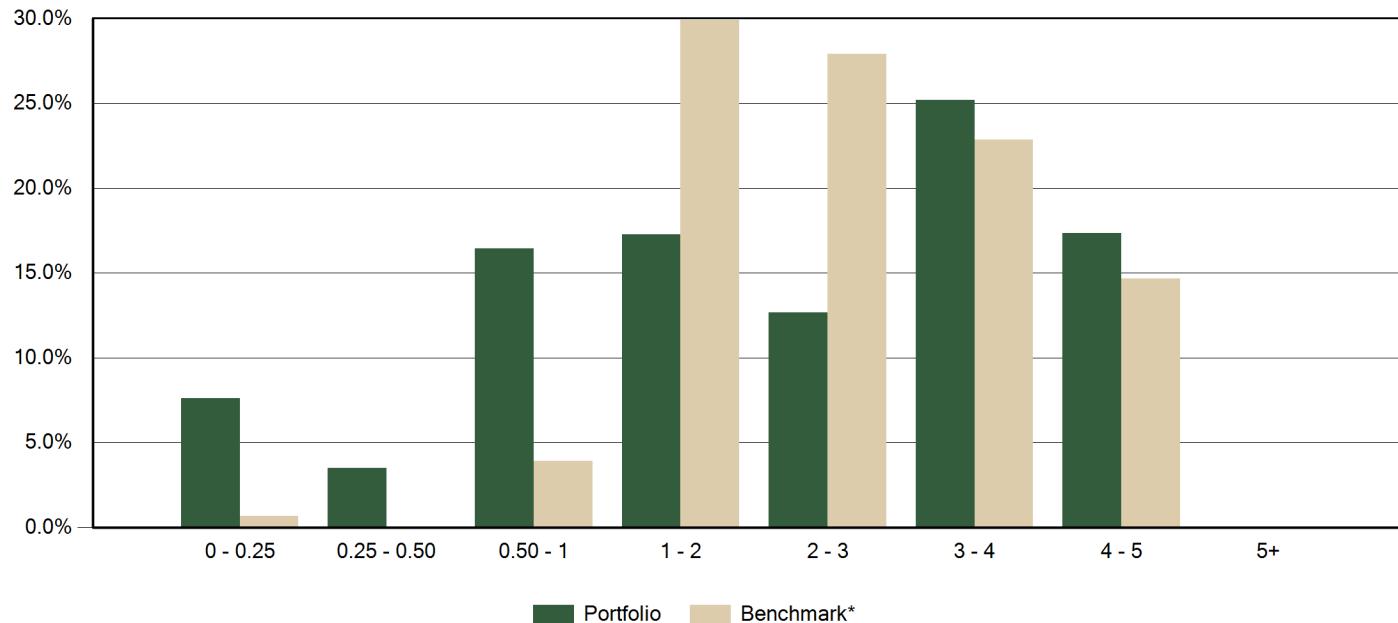

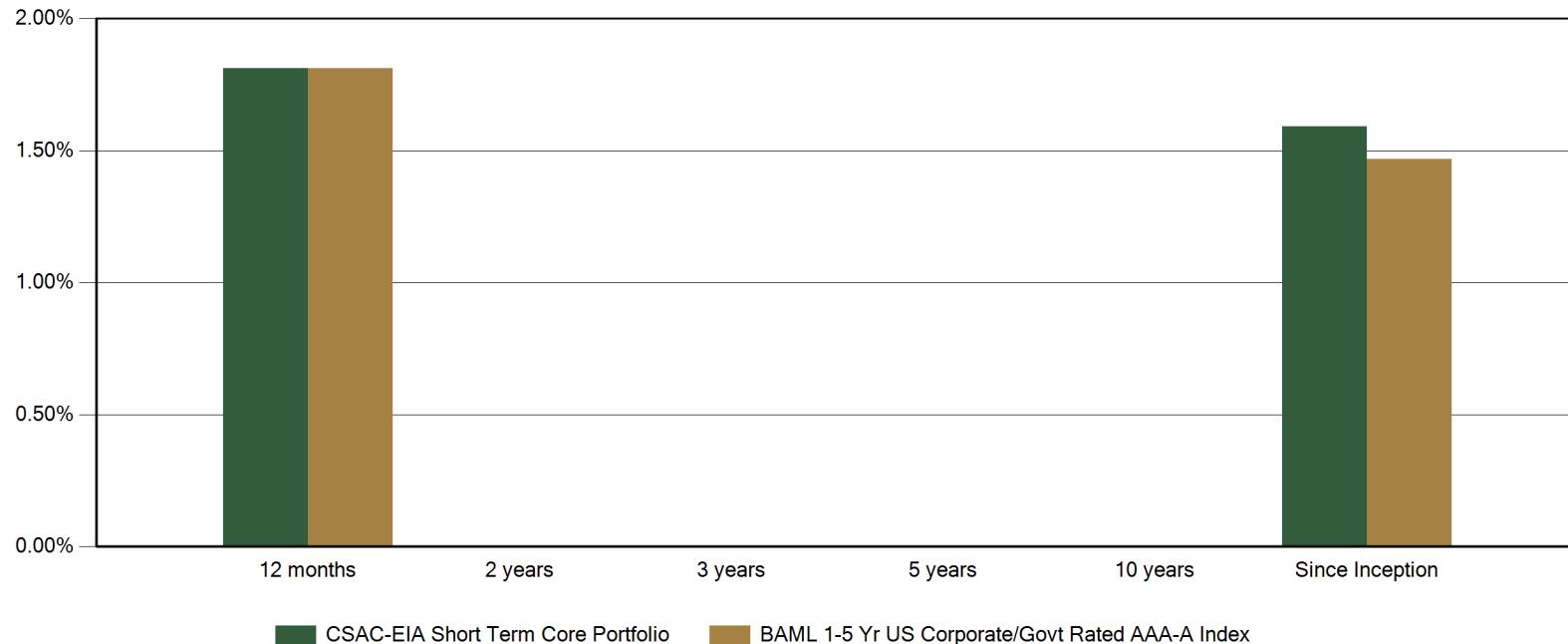

September 30, 2016 vs. June 30, 2016



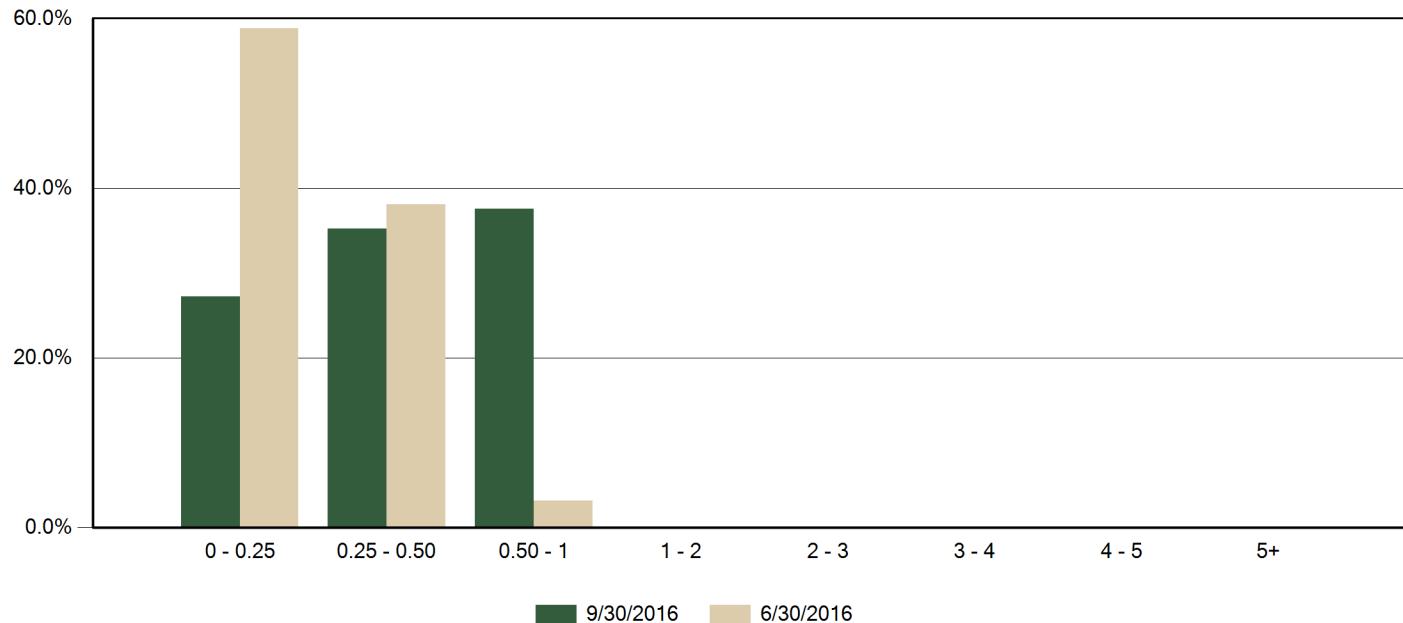

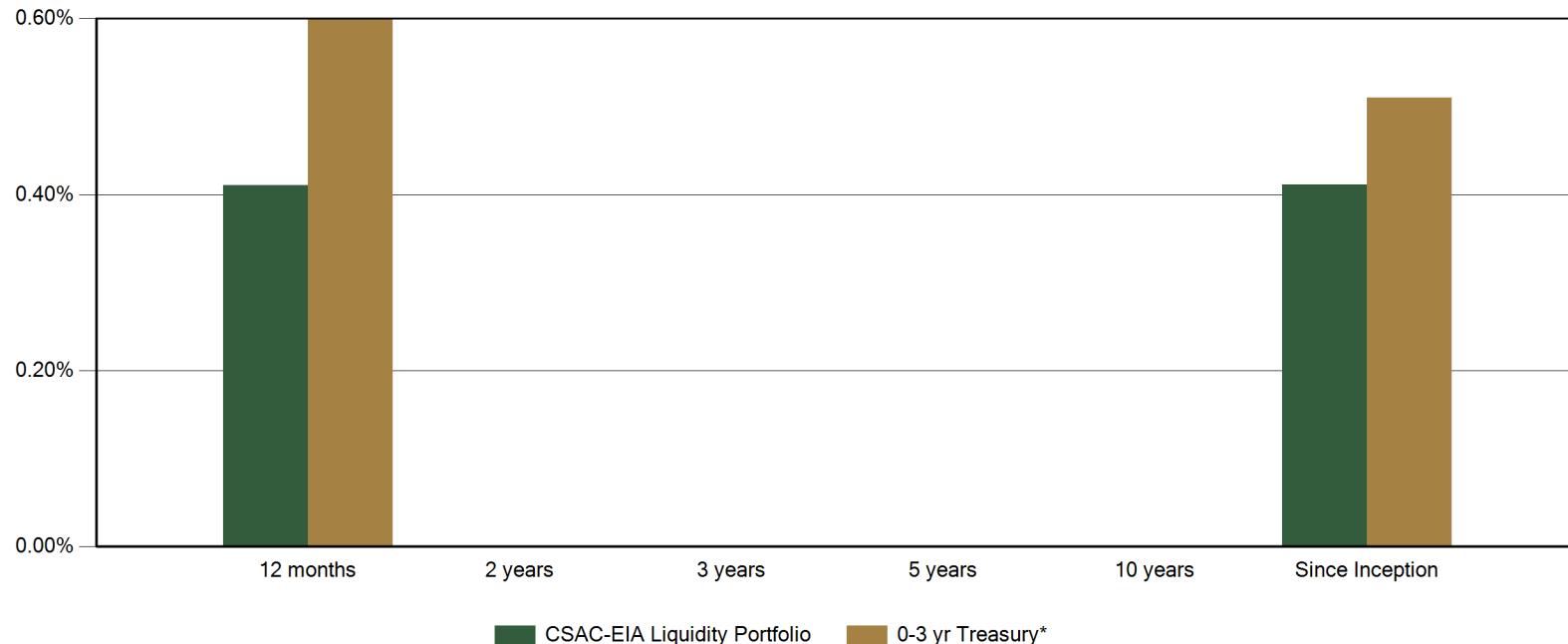

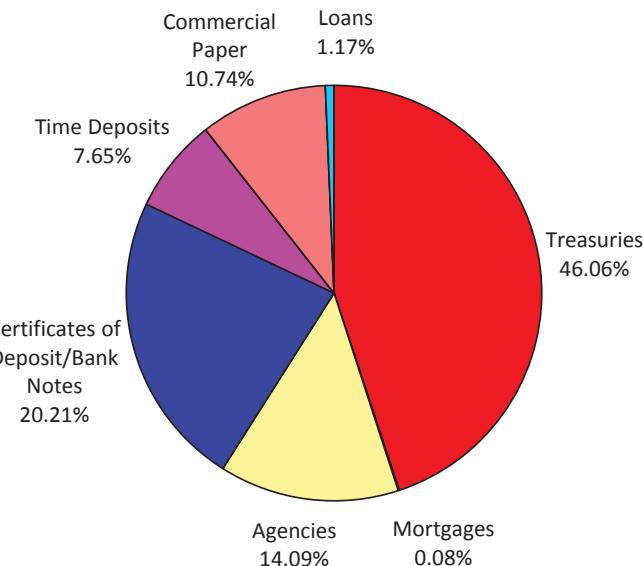
