Program Performance Report (PPR)

Andrew Guzman, City of Visalia

Staff presented the PPR, updated through October 31, 2023. Premium volume for all combined program segments is \$557M, with medical/pharmacy claims and fixed costs totaling \$547.5M, resulting in a program funding ratio of 98.4%.

<u>Express Scripts (ESI) Contract Amendment – Low Wholesale Acquisition Cost</u> <u>Drug Rebate Reconciliation Strategy</u>

Alliant provided background information regarding the ESI rebate program, and how the availability of biosimilar drugs is affecting the marketplace. The Committee approved a contract amendment that would update the way ESI calculates rebates for the PRISMHealth program. Noting concerns regarding ESI rebate calculations, the Committee also approved the utilization of program Performance Guarantee Funds to contract with a third-party firm to conduct an audit of ESI's manufacturer rebate contracts.

Pharmacy Benefit Manager (PBM) Request for Proposal

Alliant informed the Committee that the December 2022 PBM Request for Proposal (RFP) uncovered questions around ESI's rebates, resulting in the withdrawal of the RFP, and a 1-year contract extension with ESI through December 31, 2024, allowing time for research of the issue. Alliant reported they will now conduct another full-market RFP with an expected effective date of January 1, 2026.
