# Program Performance Report (PPR)

Staff presented the PPR, updated through May 31, 2023. Premium volume for all combined program segments is \$277M, with medical/pharmacy claims and fixed costs totaling \$269M, resulting in a program funding ratio of 97.2%.

## **New Member Applications**

The Committee approved Glenn County and San Diego County Regional Airport Authority for entry into the PRISMHealth Program, large member segment, effective January 1, 2024.

## New Member Application – Shasta County

Staff and Alliant presented Shasta County for consideration for membership in the PRISMHealth Program, large member segment, effective January 1, 2024. Staff presented that although the Committee had previously established a no-exception underwriting guideline for carve-outs, exceptions can be made. Alliant assured the Committee that the County's risk can be separately reviewed. The Committee expressed their concern about this exception to the program's Underwriting Guidelines, and that approving the County for membership sets a precedent with as-yet-unknown ramifications. The Committee voted not to approve Shasta County for membership in the Program at this time.

The Committee approved Ventura County, in representation of the Ventura County Deputy Sheriffs Association, for entry into the PRISMHealth Program, large member segment, effective January 1, 2024

#### Anthem LiveHealth Online (LHO) Program Enhancements

The Committee approved the expansion of Anthem LHO program services to include access to dermatology and sleep care, covered at member-specific specialty copays, for all PRISMHealth Anthem members and plan types (HMO/PPO/HDHP/EPO), effective September 1, 2023.
