The report was prepared by the EIA and has been audited by independent auditors, Gilbert Associates, Inc., CPAs and Advisors. Included in the report is the "Management's Discussion & Analysis" (MD&A) which provides highlights of the EIA's financial position in an easy to read, narrative format and is supported with graphs and other illustrations.

The EIA was awarded a Certificate of Achievement for Excellence in Financial Reporting for the 2013 CAFR by the Government Finance Officers Association of the United States and Canada (GFOA). A Certificate of Achievement is only valid for one year. The EIA has submitted the 2014 CAFR to the GFOA to determine its eligibility for another certificate.

### Elimination of Loss Prevention Platform User Fees

EIA Loss Prevention is happy to announce that effective January 1, 2015, we will no longer assess user fees for the Loss Prevention Platform and Employer Pull Notice programs. This change does not apply to the premium content libraries (Fire/EMS, Water/Wastewater, and Law Enforcement). Members utilizing premium content will continue to contract directly with TargetSolutions for those libraries at a pre-negotiated, reduced rate. We have also entered into an agreement with our partner TargetSolutions to extend our relationship through the end of the 2020/2021 year. These measures were approved by the Executive Committee at its September 4, 2014 meeting in an effort to achieve long term budgetary stability and continued growth of the program.
